Mr. Montuore motioned to convene the Executive Session. Said motion was seconded by Mrs. Michalowski and carried by unanimous vote.

Motion was made by Dr. Carollo to adjourn the Executive Session and reconvene the Regular Meeting at 7:07 pm. Said motion was seconded by Mrs. Michalowski and passed by unanimous vote.

In attendance: District Administrators and members of the general public.

SUPERINTENDENT'S REPORT – Dr. Ronzitti reported on the following:

- Enrollment to begin the 2010/2011 school year is 1,041 students.
- Two fire drills were conducted at all three schools in June 2010 and July 2010. Brooklake School completed a "shelter in place" drill on June 1, 2010.
- Dr. Ronzitti gave an update on consolidation. There has been no communications on any level from the date of the last meeting.
- Dr. Ronzitti reported that the next "One Day, One School" event will take place on October 2, 2010 in the district as well as at the Hanover Park Regional High School District. The "One Day, One School" program is rolling out a new program sponsored by associate business members who will offer discounts to residents displaying the program's wristband.
- Dr. Ronzitti reported that under very unique and difficult circumstances, mainly the
 absence of two building principals, the opening of school went very well. Dr. Ronzitti
 thanked Dr. Caponegro and Mr. Christ as well as the district staff who demonstrated
 professionalism and whose additional efforts made the opening look easy. Dr. Ronzitti
 stated that Dr. Maricle is doing well.
- Dr. Ronzitti and Mr. Infantolino recognized and thanked Mrs. Tobias and her husband for alerting the district to an opportunity to purchase slightly used furniture to replace various workstations and all district teachers' chairs from a company that is moving its headquarters. The furniture was purchased for pennies on the dollar.
- Dr. Ronzitti gave a brief summary of UAC/RAM.

- Dr. Ronzitti thanked Mr. Infantolino for all of his efforts and spearheading the initiative to install a comprehensive recycling program throughout the district. Mr. Infantolino met on many occasions over the summer with employees of the MCUA and scheduled six assembly moments for the staff and students to start the school year. The program has been well received and operating nicely.
- Dr. Ronzitti stated that he received word late today that Federal funding under the EDJobs bill awarded to the State of NJ (\$268 million) has been allocated to districts. The Florham Park Public School district will be receiving approximately \$27,000.00.

A member of the general public provided information on behalf of the Red Cross on babysitting program designed to provide young male and female students certification on CPR etc. Literature was provided to Mr. Majeski for review and future guidance. A member of the general public commented that the board should consider options for the FY2011 Ridgedale Middle School graduation ceremony to ensure the presence of Mr. Majeski, Ridgedale Middle School Principal in the event the is a scheduling conflict this year as there was in FY2010.
