E.SUPERINTENDENT'S REPORT

- Dr. Ronzitti reported that enrollment to date is 1,022.
- Dr. Ronzitti stated that the district has developed and enacted policies and procedures as required by the new HIB "anti-bullying" legislation. Dr. Ronzitti reported that as of this date 15 incidents have been reported and investigated. 13 were adjudicated as non-bullying and the other two were adjudicated with consequence. One received a parent conference with a 5 hour detention and a recommendation for counseling the other was adjudicated with assigned bus seating.
- Dr. Ronzitti reported that NJ Monthly listed Florham Park as the 6th best place to live in NJ. One of the top rankings in northern NJ as well. Dr. Ronzitti stated that this is a testament to the the school district and the municipality as the criteria for ranking weighs heavily on student achievement, tax rates and crime.
- Dr. Ronzitti reported that Dr. Maricle has completed the first of three sessions on training substitutes in the district. This training is mandatory for our substitutes. They will not be used in the district if training is not completed.
- Dr. Ronzitti stated that nothing formal has been discussed regarding consolidation, however a few education association have started to speak to the issue again.
- Dr. Ronzitti stated that Mr. Philip Infantolino, CEFM, Supervisor of Buildings and Grounds is scheduled to be recognized for his achievements in establishing a district recycling program by the Morris County
