## **E.SUPERINTENDENT'S REPORT**

• Mr. Rubano welcomed everyone to the meeting. Mr. Rubano commented that the ESY13 Program concluded on 8/13/13. The program was implemented successfully. The program conducted the necessary drills on 7/18/13 and 7/29/13. There were no instances under HIB reported during the ESY13 program period.

- Mr. Rubano stated that the current enrollment for the upcoming 2013/2014 school year is 1,003.
- Mr. Rubano reported that 9/13/13 has been added to the school calendar as "in session". The district will make numerous and various notifications leading up to that date.
- Mr. Rubano reported that all instructional staff had been hired for the upcoming school year.
- Mr. Rubano reported that the "summer custodial/maintenance" program has ended. Mr. Infantolino stated that all the students provided great effort and a positive attitude. Ms. Rena Hendrick, Interim County Executive Business Administrator conducted a preliminary walkthrough as part of the QSAC process with Mr. Csatlos and Mr. Infantolino. Ms. Hendrick provided guidance during the exit conference to remedy various issues, but on a whole was very pleased with the facility and department staff.
- Mr. Rubano stated the State of New Jersey DOE Department of Special Education Review found the district in compliance in all aspects of Special Education requirements.
- Mr. Rubano reviewed first round scores for the NJASK testing.
- Mr. Rubano reported that on 8/8/13, he met with Chief Montuore, Sgt. Bartell and Officer Greenstien to discuss DARE and GREAT programs as well as review the Uniform Memorandum of Agreement. Mr. DeCoursey and Mr. Montuore have executed the agreement.
- Mr. Rubano is in receipt of and will distribute a flyer notifying parents of an upcoming special election regarding a Hanover Park Regional High School bond referendum.

WHEREAS, the Lead Agency will from time to time during the Effective Period (from date of adoption through May, 2018 hereinafter referred to as "Effective Period") issue one or more Requests for Bids for electric generation services on behalf of the ACES Cooperative Pricing System pursuant to the Public School Contracts Law and EDECA; and

WHEREAS, due to significant volatility and the potential for price increases in the wholesale electric market, Participating Members will preauthorize the Lead Agency to award contracts for Electric Generation Service in each service territory to one or more electric power suppliers that submit bids which are reasonably forecasted to provide estimated savings to the Participating Member based upon its previous electric usage and utility provided Basic Generation Service rates; and

WHEREAS, the Lead Agency will only award contracts for said electric generation services to electric power suppliers that submit bids with pricing reasonably estimated to be lower than the utility-provided basic generation service; and

**WHEREAS**, the District agrees to purchase all electric power needed for its own use (exclusive of onsite electric generation sources) during the Effective Period through any electric power supplier(s) awarded a contract, it being understood that the term of any one contract shall be subject to the provisions of Public School Contracts Law;

**WHEREAS**, the Lead Agency will notify the Department of Community Affairs' Division of Local Government Services by mail prior to the issuance a Request for Bids for electric generation services, with the understanding that if the Division of Local Government Services does not respond within 10 business days, it will be deemed to have approved the issuance of the Request for Bids or the Request for Rebids.

**FURTHER RESOLVED** that the Lead Agency of the ACES Cooperative Pricing System is hereby authorized to execute a master performance agreement that obligates the district to purchase electricity at the terms and conditions stated therein with a third-party supplier or suppliers who have been awarded the contract or contracts by the Lead Agency on behalf of the participating members of the ACES Cooperative Pricing System #E8801-ACESCPS (or any CPS number to be assigned in the future), and provided further that all such contracts shall be at prices reasonably forecast and estimated by the Lead Agency to provide savings to the Districts relative to the price charged for basic generation service by the electric public utility that would otherwise provide such service; and, be it

WHEREAS, the District agrees to purchase all Natural Gas Supply Services for its own use during the Effective Period through any natural gas supplier(s) awarded a contract, it being understood that the term of any one contract shall be subject to the provisions of Public School Contracts Law; and

**WHEREAS**, the Lead Agency will notify the Department of Community Affairs' Division of Local Government Services by mail prior to the issuance a Request for Bids for natural gas supply services, with the understanding that if the Division of Local Government Services does not respond within 10 business days, it will be deemed to have approved the issuance of the Request for Bids or the Request for Rebids.
