## **E.SUPERINTENDENT'S REPORT**

- Mr. Rubano stated that the current enrollment for the 2013/2014 school year is 1,014.
- Mr. Rubano reported that there was one (1) incident reported since the last meeting. The incident was reviewed and dismissed as not HIB. There have been no HIB incidents to date.
- Mr. Rubano reported that the district winter performances have been outstanding. The district's music program is to be commended.
- Mr. Rubano shared communication form Operation Shoe Box, commending the efforts of Miss Gina Bianco
- Mr. Rubano stated that the district has been awarded a \$1,000 safety incentive grant from NJSIG for completing all the requirements during the 2012/2013 fiscal year.
- Mr.Rubano reported the following drills conducted in November; RMS 11/1/13 Shelter in Place, 11/14/13 Fire, BLK 11/12/13 Code Orange, 11/25/13 Fire and BWD 11/14/13 Lock Down, 11/22/13 Fire. Mr. Rubano stated that he has attended many drills this year and commended the administration, staff and student for the serious nature of the exercises.
- Mr. Rubano stated that in September the board approved grant applications to the SDA for Construction Grants. The district received approval last week. The district may receive up to 40% of the eligible estimated costs of \$1.5 million dollars or \$600,000.
- Mr. Rubano recognized the effort of Mr. Infantolino and the entire custodial maintenance department for their efforts over the past two weeks preparing the district during the winter weather.
