G. <u>SUPERINTENDENT'S REPORT -</u> Dr. Varley reported the following;

- RMS and BKL Geography Bee Award Presentation Dr. Caponegro introduced and awarded certificates as follows; Adam Haydoutov(champion), Henry McCann, Peter Dougherty, Courtney Irwin, Anika Lippke, Liam Bill and Mackenzie Dougherty. Mr. Christ introduced and awarded certificates as follows; Andrew Modrowsky(champion), Christian Peterson(2nd), Anthony O'Day(3rd), James Dwyer, Shenlila Huq and Mary Korab. BKL Science Fair Exposition Showcase Dr. Caponegro stated this year's participants were the largest group in school history.
- BKL Peer Leadership Program Certificate of Appreciation Presentation Dan Aronoff Dr. Caponegro
 introduced students Courtney Irwin and Sienna Petro who presented their experience as peer
 leaders. Dr. Caponegro introduced Mr. Dan Aronoff, of FDU and presented him a Brooklake School
 Certificate of Appreciation. Mr. Aronoff thanked the Board of Education for allowing the program and
 partnership to exist.
- 1:1 Initiative Mr. Christ, Mr. Silkensen, Mr. Stiles and Mr. Esposito narrated a powerpoint on the middle school 1;1 chromebook initiative. The program covered the program highlights, use of equipment, student achievement and applications of learning.
- Charlene Peterson, Morris County representative of NJ School Boards Association narrated a powerpoint on Board Member Ethics.

I. COMMITTEE REPORTS

<u>Policy</u>- Mrs. Cali stated the committee met to review all items on the agenda this evening. Based on new court decision all individuals contained on the personnel agenda received a "RICE" letter.

Curriculum- Mr. Shanley stated the committee discussed the Teachers' College of Columbia and Piloting a new Unit of Study in Florham Park. BSI was discussed focusing on the need to incorporate lesson plans. The middle school math program needs improving to address below average scoring in relation to surrounding districts. The committee also discussed, standards based report cards, the 2/16 inservice and the next generation science standards.

Personnel- Mrs. Cali stated that all items within the personnel grid were reviewed. Based on new court ruling, all persons on the personnel agenda received a "RICE" letter.

Finance/Facility- Mr. Ritirvi stated the committee met on 2/13, 2/17 and 2/21. The first two days was a thorough review of budget items with the administration. 2/21 was a recap as well as discussing all financial statements and the SEMI program waiver on the agenda. Under finance the committee discussed the repairs to a roof leak at Brooklake and a vent leak at Ridgedale. A new truck is needed for replacement in the maintenance/grounds department.

Transportation - Mrs. Crimi stated the complaint/compliment log was reviewed as well as the misconduct log. Concerns were raised about repeat offenders and progressive discipline.

H.P.R.H.S Articulation- Mrs. Crimi attended and learned about the Student Sustainable NJ Program Teacher Administrator Board- Mrs. Cali stated the committee met a spoke highly of the Teacher's College Readers Workshop program. Great success of the Briarwood Buddies program. Science to science was well received as was mindfulness. There has been an increase in the instrumental music program. Dr. Varley is considering and surveying parents through the PTA regarding move to delayed openings for professional development.
