1. FY18 TENTATIVE BUDGET-TRAVEL AND RELATED EXPENSE REIMBURSEMENTS

WHEREAS, the tentative budget includes the following appropriations Legal \$ 37,500.00 Auditor \$25,500.00 School Physician \$ 22,300.00 Financial/Other Advisory \$ 8,350.00: and

WHEREAS, the administration needs to notice the board if there arises a need to exceed said maximums, upon which the board may adopt a dollar increase in the maximum amount through formal board action; and

WHEREAS, the Board and Administration wishes to minimize the amount of paperwork involved in this area;

NOW, THEREFORE BE IT RESOLVED,

that the Florham Park School District Board of Education establishes maximums for professional services listed above at a level of 120% of the amounts listed for the 2017-2018 school year.

BE IT RESOLVED, the district will use its taxing authority for the 2017-2018 school year composed of \$137,185.00(.81%) for health benefits adjustment which are available to the district for the school budget for 2017-2018, in addition to the 2% increase over the prior year which totals \$475,198.00 resulting in a maximum tax levy available of \$17,375,847.00. The district will bank additional tax authority for use in FY 2018-2019 of \$3,841.00.

Discussion: Mr. Ritrivi highlighted some of the points within the budget and the committee will examine going forward. Mr. Ritrivi stated that district capital reserve will be utilized to fund the replacement of the Ridgedale Roof, the district will examine copier costs at the conclusion of the current lease in March of 2018 as we use less paper. Mr. Ritrivi stated request for proposals will be made for various professionals in an effort to save monies. Discussion ensued regarding legal services, specifically the cost, prior experience and the proper use of services.

F. PUBLIC COMMENT: Mr Winters asked about the .81% increase in the tax levy for benefits. Mr. Csatlos stated the district qualified for the additional tax increase due to health benefit increases i.e. medical was rising 8.4%. Mr. Winters asked about the capital project and the term otherMr. Csatlos gave an overview of the project and stated that the term is to account for any unforeseen repairs that must be made once the roof is off. Mr. Winters asked about staff retirements. Mr. Csatlos stated only one staff member has indicated retirement and that is accounted for in the budget.

Mr. Zuckerman stated that the school budget continues to rise despite dropping enrollment. He questioned the rationale in increased administration.

There were no further questions

Mrs. Rozek stated the board needed to convene an executive session this evening to review a personnel matter, specifically the prospect of hiring a new payroll/benefits specialist.
