D. SUNSHINE STATEMENT:

In accordance with the Open Public Meetings Act, (Chapter 231, P.L. 1975), adequate notification of this meeting has been provided by advertising in the <u>Morristown Daily Record</u> and the <u>Madison-Florham Park Eagle</u>. In addition, notices were posted at the Municipal Clerk's Office, Public Library, and the Board Administration Office at 67-71 Ridgedale Ave at least 48 hours prior to the meeting.

E. WORK SESSION UPDATE: Dr. Caponegro and Ms. O'Connor presented:

- Distance Learning Update Dr. Caponegro reported out on how things are going. Ms. Heinold had concerns about the use of live tutorials and discussion vs pre-taped. The board discussed at length the merits of both. Ms. Crimi had concerns regarding Zoom and security. Mr. Stiles and Dr. Caponegro addressed this topic and how the district worked with company representatives for over two weeks prior to our roll out.
- Spring 2019 NJSLA Science Results/Analysis
 - NJAC 6A:8-4.3(a) 60 day requirement
 - NJAC 6A:30 Evaluation of performance requirement
- NJSLA Science Results 2019 presentation Ms. O'Connor stated the NJSLA is a federally required state assessment based off of the NJSLS Science. This test focuses on the new standards, literacy based reading and writing comprehension, and inquiry based learning. On average the 202 students in Florham Park out performed the state by every measure. In grade 5 domain physical science was identified as a source of strength and the domain life science is an area of growth. 42.8% of Grade 5 students scored at levels 4 and 5. 36.1% of Grade 5 students scored at levels 4 and 5. In grade 8 domain Earth and Space was identified as an area of strength and the domain life science is an area of growth. The district will evaluate the curriculum, pacing guide, and curricular materials to address this need. We will also be looking at ways to target underperforming students.
- Through the QSAC process we identified a way to improve our communication to the public. We have created a new curriculum page on the website.

H. OLD BUSINESS/NEW BUSINESS: Mr. Csatlos reported:

- **Finance Award of Contracts -** Three resolutions will be read into the minutes for passage this evening. These are the final contracts for year 1 of the referendum. The total of all year 1 projects is within the base budget and the district has full year 1 contingency remaining.
- Finance Legislation to Delay Property Tax Transmission Mr. Csatlos provided background on this resolution from NJSBA. Mr. Csatlos informed the Board of the current process to raise taxes and schedule to pay taxes to the school district. He also informed the Board of the Borough's ability to execute short term borrowing.
- Finance Donation of Surplus Personal Protective Materials Mr. Csatlos provided background on the district's use of PPM. The district has taken an inventory and has identified a level of surplus for donation to the Borough while protecting our own staff.

4. Opposing Delay in Transmission of Property Tax Revenue to School Districts

WHEREAS, Assembly Bill 3902, currently pending in the State Legislature, would authorize the Department of Community Affairs to permit municipalities to delay the transmission of property tax revenues to school districts during gubernatorial-declared emergencies; and

WHEREAS, New Jersey's public schools are highly dependent on property tax revenue to support education programs; and

WHEREAS, on average, local property taxes constitute close to 94% of the Florham Park Public School revenue; and

WHEREAS, a delay in payments from municipalities would result in a financial crisis for school districts, seriously disrupting the educational process—and bringing it to a halt; and

WHEREAS, although public school buildings are closed during the current health emergency, the education of our students is taking place through remote learning and home instruction; and

WHEREAS, continued timely transmission of school property taxes is critical for the education process to continue without interruption; and

WHEREAS, even though municipalities are designated as the authorities to collect property taxes, these taxes are levied for specific purposes—e.g., municipal, school, county, fire district—and these obligations must continue to be met; and

WHEREAS, as currently written, A-3902, which is intended to ease a financial burden on municipalities, would place a severe strain on school districts and the students and families that they serve; and

WHEREAS, the Florham Park Board of Education recognizes the impact of the current public health emergency on the state and local governments, as well as local school districts, but believes this legislation would worsen the situation for our communities.

NOW, THEREFORE, BE IT RESOLVED that the Florham Park Board of Education urges the State Senate and the Governor to oppose A-3902; and be it further

RESOLVED, that this resolution be delivered to Governor Phil Murphy, State Senate President Stephen M. Sweeney, Assembly Speaker Craig Coughlin; and the Borough of Florham Park Legislative District's representatives Senator Richard J. Codey, Assemblywoman Mila M. Jasey and Assemblyman John F. McKeon; and be it further

RESOLVED, that copies of this resolution be sent to the New Jersey School Boards Association.
