Mr. DeCoursey read the following press release to be issued tomorrow along with fact-finding report.

#### PRESS RELEASE

On Friday, July 17, 2015, the Florham Park Board of Education ("Board") received the report from the independent, State-appointed fact-finder regarding the teacher negotiations. The Board has reviewed the report and has accepted the independent fact-finder's report at a Special Public Board Meeting on July 29, 2015.

We believe that the report provides for a fair settlement and we ask that the Florham Park Education Association ("Teachers' Association") also approve and accept the fact-finder's report, so we can settle the negotiations now and move forward.

The fact-finder's report was based on the data and evidence presented by both sides at a fact-finding hearing held on May 14, 2015. The fact-finder's job is to evaluate the data and provide a recommendation for a fair settlement. Both the Board and the Teachers' Association approved the independent State-appointed fact-finder before the process started.

If both parties accept the report, then the contract will be settled. The Board on July 29, 2015 has accepted the report and if the Teachers' Association does not accept the report within 20 days of its issuance, the Public Employment Relations Commission will appoint a super-conciliator to further assist the parties. There is no set time limit to reach an agreement in super-conciliation.

Again, to bring closure to these negotiations and to settle the teachers' contract, the Board has accepted the independent fact-finder's report and encourages the Teachers' Association to do the same.
