The Business Administrator/Board Secretary of the Board of Education of Florham Park Borough in the County of Morris, State of New Jersey, by authority of said Board, will receive sealed bids at the Business Office of the Board of Education, 67-71 Ridgedale Avenue, Florham Park, New Jersey, on Friday, February 22, 2019:

BID #19-01. For the Sale of One (1) 2002 Used 54-Passenger Bus, One (1) 2006 Used 54-Passenger Bus, One (1) 2006 Used 24-Passenger Bus, and Two (2) 2004 Used Pick-up Trucks.

Notice is hereby given that sealed bids for the sale of the above vehicle will be accepted by the Florham Park Board of Education. Bids must be received at the Business Office of the Florham Park Board of Education, 67-71 Ridgedale Avenue, Florham Park, NJ, by Friday, February 22, 2019, at 2:00 p.m., at which time they will be opened and read.

Bids must be enclosed in a sealed envelope bearing the name and address of the bidder, clearly marked "SEALED BID - SCHOOL VEHICLES" and addressed to the Florham Park Board of Education. For more information or to view the vehicle, please contact Mr. John Csatos, School Business Administrator at 973-822-3880 X 1005. An inspection by the bidder is not required, however suggested.

A **suggested** minimum bid is set for each vehicle, and it will be sold "AS IS." Sealed bids shall contain a deposit of fifty (50%) percent (no cash) of the total amount bid, in the form of a certified check or money order. The balance of the amount due must be paid by certified check or money order, made payable to the Florham Park Board of Education within ten (10) days following approval of the sale by the Board of Education, anticipated on Friday, February 22, 2019 and prior to the delivery of the vehicle sold to the purchaser. The sale vehicle must be removed from the Board of Education property located at 67 Ridgedale Ave., Florham Park, NJ, by the purchaser no later than Friday, March 22, 2019.

All unsuccessful bidders will have their bid offer returned. All bids must be submitted on a bid form which will be furnished upon application at the Business Office of the Board of Education, and bids not submitted on such form may be rejected,

The Board of Education reserves the right to reject any or all bids, in whole or in part, or to make an award to such bidder or bidders who, in the judgment of the Florham Park Board of Education, make the most advantageous bid, and to waive such informalities as may be permitted by law.
