Approaching maximum character limit.

The district provides an in-person instructional model that incorporates the use of google classroom/sheets activities, online programs and use of Zoom/Google Meet for in-class assignments, and data analysis to meet the individual needs of students while adhering to the curriculum approved by the Florham Park BOE. Through the use of certified staff, PD, I&RS, contracted services, the CST, BSI and the ESL department, the district continues to provide multi-tiered, intervention services to address students' academic and SEL needs. The district operated summer ELA/Math 2022 sessions for at-risk students and an ESY program for eligible students. Through the use of district counselors, CST/Service Providers, district parent trainings, the district's SEL curriculum and contracting with CarePlus of NJ, NextMark-Mental Health, and ProjectPride, and working with the Traumatic Loss Coalition of Morris County, the district provides SEL/mental health intervention services to the school community

Describe how the LEA sought public comment on its plan and how it took those public comment into account in the development of its plan. (549 of 1000 maximum characters used)

This plan has not changed since last submitted and approved. The district provided the opportunity for public comment at the open public board of education meeting that took place on August 29, 2022 when discussing The "Emergency Virtual or Remote Instruction Plan for the 2022-23 School Year" and and was also provided with an additional opportunity for public comment at the November 28, 2022 BOE meeting. The same plan will be again BOE approved at the June 29, 2023 Board of Education Meeting with an additional opportunity for public comment.
